

Official Giveaway Rules: We'll Reward You For That Sweepstakes

NO PURCHASE NECESSARY TO ENTER, PLAY OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. THE FOLLOWING GIVEAWAY IS INTENDED FOR PLAY IN THE CONTIGUOUS UNITED STATES ONLY. DO NOT ENTER THIS GIVEAWAY IF YOU ARE NOT A LEGAL U.S. RESIDENT LOCATED IN ONE OF THE 48 CONTIGUOUS UNITED STATES.

ELIGIBILITY: The We'll Reward You For That Sweepstakes (the "Giveaway") is open only to legal residents of the 48 contiguous United States (including the District of Columbia), who are 18 years of age or older at the time of entry. Employees of Orbitz, LLC ("Orbitz" or "Sponsor") and RML Distribution Domestic LLC (together with Orbitz, the "Giveaway Entities"), as well as the immediate family members (spouse, parents, siblings and children) and household members of each such employee, are not eligible to participate or win. Void in Alaska, Hawaii, and where prohibited or restricted by law. Giveaway is subject to all applicable federal, state, and local laws and regulations and these Official Giveaway Rules ("Rules").

GIVEAWAY TIMING: The Giveaway begins at 7/20/15 at 6am CDT until 9/13/15 12pm CDT (the "Promotional Period") and consists of 8 weekly entry periods (each a "Weekly Entry Period").

HOW TO ENTER: To enter, visit www.orbitz.com/mktg/orbitzpromotions and follow the directions to enter your email address, Twitter handle (optional), and upload one digital photograph or video (depending on the Weekly Entry Period) that illustrates the theme for the Weekly Entry Period (an "Entry") and complies with the requirements outlined below.

Each Entry must comply with the following requirements:

- Photographs *must be in* jpg, .jpeg, .gif, or .png format and no larger than 3 MB.
- Videos must be in .wmv., .mov, .mpg, or .mp4 and no larger than 30MB.
- Photographs and videos may not have been previously published or submitted in any other contest.
- Photographs and videos must be original. Any modification of an existing photograph/video, computer/electronically altered photographs/videos or any other modification of a photograph/video taken by the entrant does not qualify as an original photograph/video.
- If more than one person appears in the photo or video entry, you acknowledge and agree you have obtained all permissions necessary to submit your photo/video.
- Photo and video submissions that include any trademarked, copyrighted, or proprietary brand name, logos, images or objects, federal, state and/or municipal buildings, monuments, flags or landmarks, any private property, landmarks, or monuments that would require approval of a third party may be disqualified if the Sponsor is unable to obtain the proper release and/or releases determined at the sole discretion of the Sponsor.

- Photographs and videos cannot defame or invade the rights or privacy of any person, living or deceased, or otherwise infringe upon any third party's personal or proprietary rights.
- Photographs and videos must be consistent with the Orbitz brand reputation in the marketplace and must be suitable for audiences of all ages. Photographs and videos that, in Sponsor's sole discretion, contain any type of vulgarity or objectionable content will be disqualified.

Limit one (1) submitted Entry per person per Weekly Entry Period. An entrant can receive an unlimited number of additional entries to the Giveaway for each Entry that is submitted by a third party by following a personalized referral link available on the Entry confirmation page. Any entrant found to be using multiple email addresses to enter this Giveaway will be deemed to be ineligible. By entering the Giveaway, each entrant agrees to become a member of the Orbitz Rewards program, if not already a member, and agrees to the terms and conditions of the Orbitz Rewards program (<http://www.orbitz.com/info/win?id=RewardsTerms>). Orbucks awarded to entrants and winners are subject to terms and conditions of the Orbitz Rewards program.

Each person who submits a valid Entry into the Giveaway will receive Orbucks, the amount of which will vary depending on the Weekly Entry Period. Each person may receive up to a maximum of \$110 in Orbucks through the Promotional Period (not including any Orbucks received as a prize); such maximum will be determined on a per person basis, and not on an email address or account basis. Orbucks will be credited on a per Entry basis, regardless of the number of people in a photo or video. A photo or video can only be submitted one time as part of one Entry, even if multiple people are in the photo or video. The Orbucks will be deposited in the submitter's Orbitz Rewards account. The Orbucks will be deposited within six weeks and will expire one year from the date of the deposit.

PRIZE WINNER SELECTION AND NOTIFICATION: The potential Grand Prize Winners of each Weekly Entry Period of the Giveaway will be chosen at random by Sponsor within 2 business days of the end of each Weekly Entry Period from all eligible Entries received by the end of the Weekly Entry Period. The potential First Prize Winners of each Weekly Entry Period of the Giveaway will be chosen by a panel of judges at Orbitz using the criteria set forth below. Non-winning Entries will not be carried over into any subsequent Weekly Entry Period drawing(s). Odds of winning depend on the number of eligible entries received for each Weekly Entry Period drawing. The potential prize winners will be notified via email from marketing@orbitz.com to the email address provided on the Giveaway entry form and will have forty-eight (48) hours from the time the email is sent to claim the prize. If the winner notification remains unanswered for more than forty-eight (48) hours, the prize will be forfeited in its entirety and an alternate winner will be selected. If any email winner notification is returned as undeliverable, the prize will be forfeited in its entirety and an alternate winner will be selected. The prize winner (*parent or legal guardian if potential prize winner is under the age of majority in his/her state of residence*) must complete, sign and return an Affidavit of Eligibility, Publicity Release, and any other necessary documents, including required tax documents. PRIZE AND APPROXIMATE RETAIL VALUE: One (1) Grand Prize per Weekly Entry Period: two (2) round-trip coach class flights on Delta Air Lines from destinations in the 48 contiguous United States to the destinations for the Weekly Entry Period (see below). Airline ticket booking is subject to availability. Connecting flights may be required. No code-share flights or upgrades allowed. At least 24 hours advanced booking is required and must comply with all Booking Guidelines provided to winner. Once the tickets have been issued, they are non-refundable and shall not be re-bartered, sold, endorsed, exchanged, transferred or in any other manner modified by the winner or the winner's travel companion. Once the tickets are issued, itineraries cannot be changed by Orbitz. Individual passengers shall be responsible for all payments of excess baggage charges, taxes and any other charges incurred after or in connection with the issuance of the tickets. Tickets must be booked by July 9, 2016 for travel up to 330 days after the booking date. Winner will not receive the difference between actual and approximate retail value.

Each weekly grand prize winner will also receive \$500 in Orbucks which will be deposited in the winner's (not the travel companion's) Orbitz Rewards account. One (1) First Prize per Weekly Entry Period: \$500 in Orbucks per Weekly Entry Period chosen by a judging panel of representatives from Orbitz. Entries will be screened and judged as they are received. Judging will be completed the week following each Weekly Entry Period. All entries will be evaluated on a 100 point scale, as follows:

- A maximum of 40 points for the Entry being relevant to that Weekly Entry Period's theme.
